Board Members,

I heard back from the owners of the Spruce Mountain South property that we proposed holding our annual meeting on 7/24. Below is the response from Dan Lehmann:

"All SMS partners participated in the discussion of the WVMTR Annual Meeting both in person last weekend and online. We still support the idea of hosting the event and look forward to days with fewer restrictions. Megan and I have done much of the putting words on paper so to speak, I have copied her in this email.

Registration like we did in 2019. The SMS owners request only vaccinated WVMTR members camp overnight on the property; there are many other places to camp in the area. Registration for camping overnight Friday and/or Saturday will be capped at 30 people, with no limit on the number of people who would like to run or attend the annual meeting on Saturday only.

Use the portojohns and outside shower, not cabin

No dogs, including SMS owners.

Some other thoughts for the week-end program.

Last time in 2019 there was a pizza dinner on Friday night. Eliminate that. Only have planned stuff on Saturday, but people can camp on Friday night if they're registered.

Begin the annual meeting sometime in the mid-afternoon so folks can get a good run in, come back and shower outdoors, eat and drink something they brought themselves from their own coolers, and then attend the meeting. End the meeting no later than 5pm so people who aren't camping can get on their way.

The whole club-sponsored hot dogs and hamburgers picnic-type activity with people bringing a dish to share can be eliminated this year. We can tell campers there's a Weber grill on-site if they want to use it. Maybe people will organize themselves to share the grill/charcoal if they want but we don't want to commit to providing food and staffing a grill for others.

Let us know what you think."

I appreciate the SMS owners' willingness to allow us to utilize the property and am sensitive to their request. What are the group's thoughts? Do we want to proceed with the Annual Meeting at SMS, under the property owners' terms, or think about another virtual meeting?

There always were more accessible locations to hold the Annual Meeting, but we've selected SMS many times because we like the area, the trails, outdoor camping, etc. By the time July 24th arrives, WV is predicted to be above 65% vaccinated, which isn't herd-immunity, but I think as close as we're going to get. I support holding the meeting at SMS and following the Owner rules.

When we decided to use SMS it was intended to be a combo of the camp/run weekend and the annual meeting so it's not just an annual meeting. I feel like saying you can attend the meeting but you can't stay the night without vaccination is the wrong message to our membership.	
It's probable that our membership is like the rest of the population which is a little less than 40% vaccinated today with demand for the vaccine waning. Even if it was 65% vaccinated by July that excludes a pretty large part of our folks.	
Even though the owners of SMS have the right to ask for the vaccination requirement I can't support WVMTR agreeing to that condition.	
If we want to make it a camp/run weekend without the meeting and require vaccinations that's fine.	
For the annual meeting either Zoom or an alternate location without any vaccination requirement would be acceptable alternatives.
